- Regardless of disbursement date, if you enter ANY award into SAFM **after June 2024 Fiscal Year End closing date** (June 20), these funds will be charged in FY 2024-25.
  
- 2023-24 budgets for **Summer Tuition** should be awarded using **Summer 1** tuition item types.
- 2024-25 budgets for **Summer Tuition** should be awarded by using **Summer 2** tuition item types.
  
- 2023-24 budgets for **Summer Fellowships/Stipends** should be awarded using **June & July** stipends.
- 2024-25 budgets for **Summer Fellowships/Stipends** should be awarded using **August** stipends.
